Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures included computer safeguards and secured files and buildings.

The types of personal information we collect and share depend on the product or service you have with us. We collect this information when you complete subscription documentation to purchase an interest in an investment offering, request more information via our website's "Contact" page, request property management or development services, etc. This information can include:

- Social Security number
- Bank account information
- Mailing address and email address
- Telephone number

When you are no longer our customer, we continue to share your information as described in this notice.

## FURTHER INFORMATION

- <sup>1</sup> Federal law gives you the right to limit only the following:
  - sharing for affiliates' everyday business purposes—information about your creditworthiness
  - affiliates from using your information to market to you
  - sharing for nonaffiliates to market to youState laws and individual companies may give you additional rights to limit sharing.
- <sup>2</sup> Affiliates are companies related by common ownership or control. They can be financial and nonfinancial companies.
- <sup>3</sup> Joint marketing is a formal agreement between nonaffiliated financial companies that together market financial products or services to you.
- <sup>4</sup> Nonaffiliates are companies not related by common ownership or control. They can be financial and nonfinancial companies.

We restrict access to information about you to those employees who need to know that information to provide services to you. We safeguard your information through written privacy policies and physical, electronic and procedural protections. We may use a commercial e-mail service to send e-mails to you, but the service is restricted from sharing your information with others, and you will have the opportunity to unsubscribe from any such e-mails in the future.
